## Browser Requirements

This documentation is based on Java technology. Proper viewing requires:

- Microsoft Internet Explorer 4.x, or higher, or
- Netscape Navigator 4.5 or higher.

For either browser, Java and JavaScript must be enabled.

In addition, your browser should be set to accept cookies.


## Navigating

The following information is provided below:

### Navigation Links

In the top right-hand corner of each page you will find navigation links that help you navigate through the documentation.



Click on the link to go to the page you wish to view or to perform the desired action.

Links that are grayed out are not active.

## Table of Contents

The Documentation Tree Navigator is a Java applet that displays a collapsible/expandable tree view of the documentation hierarchy. You will find the Tree Navigator useful in finding your way through the documentation web.

You can call up the tree navigator by clicking the CONTENTS link in the navigation bar. The Tree Navigator is displayed in a separate window.



No Frames

If you encounter problems using the Tree Navigator, you may have to upgrade your browser version. See also Browser Requirements.

### To use the Tree Navigator

1. Click a plus sign to expand a part of the tree and to show further pages.
2. Select the page you wish to view and click the "Display page" button.  
The page is displayed on the right side of your browser.

## Full-Text Search

When reading the documentation directly from CD-ROM or from hard disk on your PC, full-text searching facilities are available.

On the Software AG Internet site ServLine24 (<http://servline24.softwareag.com>), you can perform full-text searches on the documentation using the powerful Adabas Web Retrieval software. All customers with valid maintenance contracts have free access to these pages.

### ▶ To start a full-text search



1. Click the Full-text Search [SEARCH](#) button at the top of the page.  
The full-text search page appears.
2. Enter the words/phrases you wish to search for and click the "Search" button.  
A list of pages containing your search criteria is shown.
3. Select the page you wish to view.  
A preview of the selected page showing the first few words of the page is displayed below the list.
4. Click the "Display page" button.  
The page is displayed and you are automatically positioned to the first occurrence of your search criteria.

### ▶ To search with the Windows NT Explorer

1. Start the Windows NT Explorer.
2. From the "Tools" menu, choose "Find > Files or Folders".  
The "Find: All Files" dialog box appears.
3. In the "Named" drop-down list box of the "Name & Location" tab, enter "\*.htm".
4. In the "Containing text" text box, enter the text string you wish to search for.
5. In the "Look in" drop-down list box, enter the top level Natural documentation directory at your site, or a subdirectory for a more specific search.
6. Click the "Find Now" button.

## Printing

The Natural documentation is available in Portable Document Format (PDF) for high-quality printing with the Adobe Acrobat Reader.

### ▶ To print the current page or book

View the current PDF book. This PDF file contains multiple HTML files. A table of contents is provided, as well.

When you click one of the above links, the Adobe Acrobat Reader starts, which opens the corresponding PDF file. You can then browse through the file and print it out.
